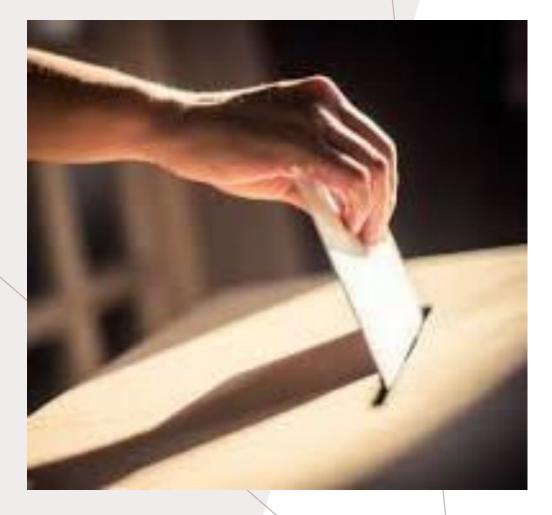

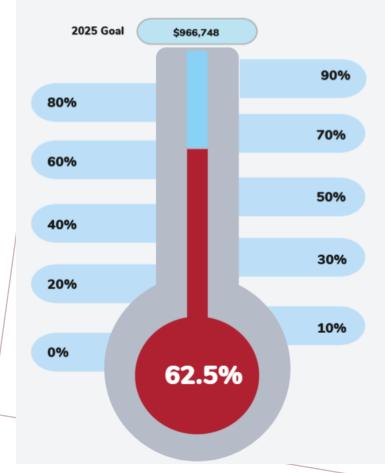

OUR PATH AHEAD...

- We've received ~50% of our expected pledge cards YTD.
- We are showing a promising trend of increasing pledges by member (as compared to 2024). *THANK YOU!*
- Changes in 2025:
 - Capital Campaign Fund renamed to Building Maintenance Fund.
 - Stewardship needs a 23% increase for operations. Asking parishioners to increase treasure and allocate their total gift to 90% for General Fund and 10% for Building Maintenance Fund.
 - Goal of 85% Building Fund participation (vs. 30% in 2024).
 - Increase ministry participation & offer talents to fulfill needs of the parish.
 - Bring back neighborhood gatherings.

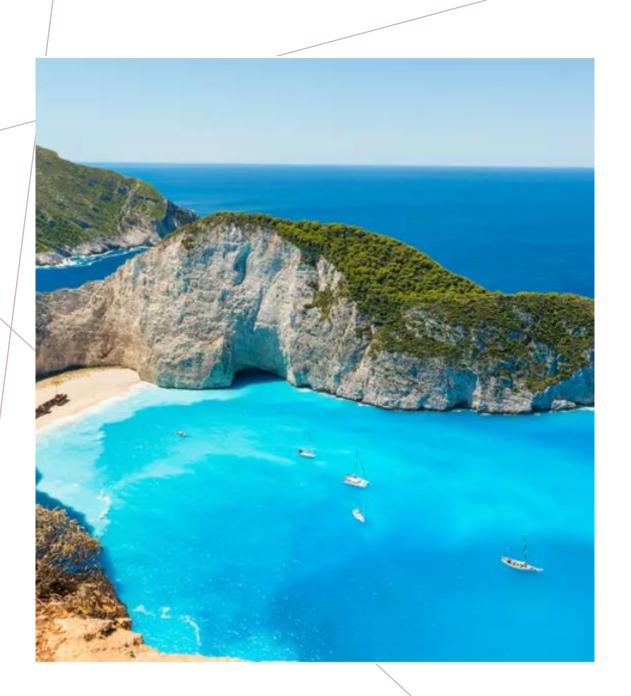

NOTABLE CHANGES FOR 2025:

1) CASHLESS ENVIRONMENT

- To better facilitate the efficient and smooth transaction process and to help cut down line-time
- To provide a better sales tracking system for future

2) Gift Cards for Volunteers/ Dancers

- No more vouchers
- Online ordering/ Volunteer Food Checkout/Register at Main Food Tent
- \$15 for 1 shift per day, \$20 for multiple.
- Flexibility in choice of food for volunteers

3)Volunteer eligibility

- Middle school age and up for all positions
- High school and up for registers
- Only known members of HT, or sister parishes (Atlanta, Cumming, PTC), or their children, to volunteer

4) Wristbands for Taverna/Bar

- New tent near admissions for ID check for 21+ wristband to help speed up bar service
- Different colored wristbands for each day to minimize attempts at circumventing this check
- provides public notice and legal protection for any instance of underage consumption

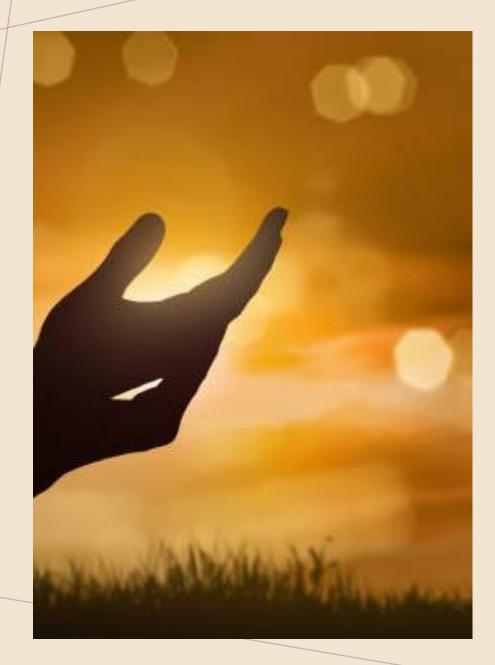
